## Investment Objective

To provide current income and preserve capital over a predetermined time period. It is anticipated that the fund will terminate on or about November 30, 2026 or such earlier date upon not less than 60 days' notice to unitholders.

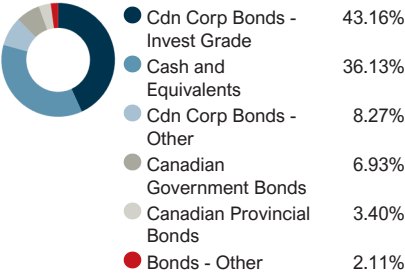
