NBI Tactical Asset Allocation Fund

The fund's objective is to ensure long-term capital growth. The fund primarily invests tactically, directly or through investments in securities of other mutual funds (that may include exchange-traded funds ("ETFs")), in fixed-income and equity securities from around the world.

- are looking to optimize the risk-return ratio of their portfolio through active management and a reduction in overall risk.

NBI Canadian Bond Private Portfolio

NBI Canadian Fixed Income Private Portfolio

To provide a high level of current income and sustained capital growth. The fund invests, directly or through investments in securities of other mutual funds, in a portfolio consisting primarily of Canadian government and Canadian corporate bonds. See the prospectus for more details.

NBI Corporate Bond Private Portfolio

To provide long-term capital growth and to generate high current income. The fund may invest approximately 40% of its assets in foreign debt securities.

NBI Non-Traditional Fixed Income Private Portfolio
